Business Visa for Canada

Canada, an economically rich country, offers immense opportunities to business visitors. Thousands of businessmen undertake short-term visits to Canada in search of new and exciting business opportunities. Under the Business Visitor visa category, foreign nationals may visit Canada for short periods to partake in business dealings with Canadian companies. The eligible applicants are permitted to explore business opportunities, interact with Canadian business counterparts, and participate in trade conferences. However, this visa does not allow applicants to assume employment in Canada. Business Visitor visa is best suited for travelers intending to experience Canadian culture, tour sites, and enjoy leisure activities while exploring various business options.

Business Visitor Visa Basic Requirements

Barring the applicants from DCO (Designated Countries of Origin) and visa-exempt countries, visitors from most nations may obtain a visa under Business Visitor category. The list of DCO is reviewed from time-to-time. Visitors from Designated countries need to obtain TRV (Temporary Resident Visa).

Applicants must possess a valid passport and ensure that they are criminally and medically permissible to enter Canada.

Business Visitors must be able to provide documentation establish their intended business activities in Canada. It is essential that visitors applying under this category should have their centre of business and the source of income and profits amassed outside of Canada.

Business Visitor Visa Entitlements

Applicants, once approved as Business Visitors, are allowed to travel across Canada. Visa holders under this category are entitled to visit family, friends, and experience Canada's cultural & tourism attractions. They can participate in trade shows and conferences; they can use the opportunity to not only meet prospective clients and take orders, but also to search for more rewarding business prospects and explore schools and educational institutions to pursue further studies. Moreover, they can conduct meetings with prospective recruiters and employers, and thereby explore options for extending their stay in Canada.

Canada Family Visa

Canada encourages family reunification. The Family Visa programs that Canada offers range of programs and opportunities for Canadian citizens and permanent Canadian residents to sponsor family members to live in Canada.

Spousal Visa

A person who is a Permanent Resident of Canada can sponsor a person as his/ her spouse if that person is married to the Permanent Resident (and the marriage performed in a legal service). A marriage between two persons of the same sex will also be recognized for immigration purposes, if the marriage was legally performed in Canada, or was performed outside of Canada in a country where marriage between two persons of the same sex is legally recognized.

Dependent Child Visa

Canada encourages familial ties. The Dependent Child visa is intended to reunite children with their

Canadian parents. This visa allows Canadian citizens and permanent Canadian residents to apply to sponsor their or their partner's dependent or adopted children who are of 19 yrs of age or below. Once approved, dependent children can join their sponsoring parent(s) in Canada. Dependent children can enjoy permanent residence and can live, study and work in Canada.

Common-Law Partner Visa

By applying for the Common-Law Partner visa, eligible applicant can stay with his/her partner (same and opposite sex) in Canada. According to this program, Canadian citizens and permanent Canadian residents can sponsor their common-law partner and (eligible) dependent children. The sponsor should intend to live with applicant and support his/her financially. Once approved, the applicant can live, study and work in Canada for an indefinite period.

Conjugal Partner Visa

Partners separated by war, discrimination or any other legal barriers can reunite via Conjugal partner Visa. This visa allows eligible (same and opposite-sex) partners to stay with his/her Canadian partner. As per this program, Canadian citizens or permanent Canadian residents can apply to sponsor their conjugal partners and dependent children. Upon approval, the applicant can enjoy permanent residence and is entitled to live, study and work in Canada.

Parental & Grandparental Visa

A Parental and Grandparental visa program allows parents and grand-parents to be sponsored by their Canadian children and grandchildren to live in Canada. The sponsors should be Canadian citizens or permanent Canadian residents. CIC will open the registration under this program in starting of every year, but only those whose number is randomly selected can apply under the program. The Canadian sponsor should be prepared to live in Canada with the applicant and support them monetarily without having any access to public funds. On approval, the applicant will be permitted to live study and work in Canada, in addition to permanent residency.

Remaining Relative Visa

Fostering the family reunification policy, Canada offers Remaining Relative visa to reunite families. Canadians who do not have any immediate family relatives in Canada or abroad, can sponsor an extended relative from abroad. Through this program, Canadian citizen and permanent Canadian resident is allowed to sponsor one relative regardless of age or relationship under the family category. Upon approval, the remaining relative will be entitled for permanent residency, work and study in Canada.

Family-Based Provincial Nominee Visa

This Family-Based Provincial Nominee visa program allows permanent residents or Canadian citizens located in specified provinces to sponsor their eligible relatives for permanent residency in Canada.

The list of provinces includes:

- Manitoba
- New Brunswick
- Newfoundland
- Nova Scotia
- Saskatchewan
- Prince Edward Island

On approval, applicants are allowed to live, study and work in Canada.

Tuition Fee

There is a separate visa office fee also that has to be paid by the student for getting the study visa for Canada once he/she meets the educational qualifications and other requirements of a particular selected course and gets letter of confirmation from the institute. The semester and annual fee of the university/college has to be paid in advance and it is refundable with a nominal deduction in case of non-issuance of visa.

Part Time Work

The students are permitted to work along with the studies on a part-time basis. Students are allowed to work 20 hours off-campus every week and can earn around CAD 12-14 per hour on an average. The average cost of living is CAD 10,000 annually.

Canada Temporary Resident Visa

Travellerswho visitCanada to explore business opportunities or visit the nation as a tourist will need a valid entry pass such as travel visa or an Electronic Travel Authorization (eTA).

Basic Requirements:-

In order to obtain a travel visa to Canada, individuals must meet some basic requirements. These include:-

- having genuine travel documents, such as a passport.
- must be medically fit
- must not have any immigration or criminal related conviction
- should be able to convince the immigration officials about their ties back home which shall persuade you to return to their native nation.
- should be able to assure the immigration official that they shall leave the Canadian nation at the end of their visit, and
- they have enough funds to support their stay in Canada and shall not seek any financial aid from the Canadian public funds.

Electronic Travel Authorization (eTA)

In effect from March 15, 2016, individuals with passports from eTA-required countries who come to the Canadian nation by air will need a valid eTA document.

An eTA is an authorization which is electronically linked to a traveller's passport and stands valid for a period of five years or until the passport expires, whichever happens first.

Applying for an eTA is simple and affordable online procedure wherein the applicants receive their authorization within few minutes after submitting their application online.

Individual who need an eTA must obtain one at least 48 hours prior to their intended date of travel to Canada to avoid any complications. Also, individuals must travel with a valid passport used for obtaining an eTA.

Visitor visa

Individuals belonging to the visa-required countries and territories must apply for a visitor visa (also known as a temporary resident visa) to travel to Canada. A visitor visa is an official document attached to a passport that allows individuals to travel to Canada.

There are two kinds of Canadian visitor visas that can be availed by individuals to travel to Canada – single entry visa and multiple entry visa.

A Canadian multiple entry visa allows visitors to come and leave Canada without having to reapply. However, each entry must not exceed six months. On the other hand, a Canadian single entry visa, as the name says, is valid only for one visit to Canada. Once you leave the geographical boundaries of Canada, except if travelling to United States, Miquelon and St. Pierre, individuals will have to apply again to travel to Canada. Both travel visa types are valid for a fixed period of time and cannot be used after they have expired.

Travel documents

When travelling to the Canadian nation, individuals must carry proper identification and travel documents as there may circumstances wherein they may be asked to furnish travel documents for verification by the Immigration officials at the Canadian airport.

The following are considered non-reliable travel documents. Individuals are not allowed to enter Canada if they are carrying:-

- a passport issued by Somalia,
- a passport that cannot be read by verification machines, issued by the Czech Republic,
- a temporary passport issued by the Republic of South Africa,
- a provisional passport issued by the Venezuelan nation.

Canadian Citizenship

Canadian Citizenship is considered as one of the most coveted citizenship in the world; and it can be obtained through legally recognized permanent residence or specific family ties.

Citizenship through Permanent Residency Canada

The resident who has maintained permanent residency status, lawfully, can apply for Canadian Citizenship through Permanent Residency Canada via this visa. Applicant can also procure Canadian passport. The applicant should be prepared to pledge of citizenship, before receiving the certificate of Canadian Citizenship. Upon approval, the applicant is entitled to avail rights of equality, legal, mobility, aboriginal peoples' rights and the right to peaceful assembly.

New Canadian Citizenship requirements have been announced by the authorities with effect from June 11, 2015.

The new requirements apply to a permanent resident, 18 years of age or older, who wish to apply for citizenship.

To qualify an applicant must:

- have, since becoming a permanent resident, been physically present in Canada for at least 1460 days in the six (6) years immediately before you apply,
- have, since becoming a permanent resident, been physically present in Canada for at least 183 days during any four (4) calendar years that are fully or partially within the six (6) years immediately before you apply,
- have met any applicable requirement under the Income Tax Act to file income taxes for any four (4) taxation years that are fully or partially within the six (6) years immediately before you apply,
- intend to reside in Canada, to work outside Canada in or with, or to accompany certain family members employed in or with the Canadian Armed Forces, the federal public administration or the public service of a province outside Canada;
- be able to communicate (speak and understand) in English or French (if you are 65 years of age or older, this does not apply), and
- be able to demonstrate, in English or French, knowledge about Canada and the responsibilities and privileges of citizenship (if you are 65 years of age or older, this does not apply).

Citizenship through Adoption

Citizenship through Adoption program allows applicant who have been adopted by Canadian parents to obtain Canadian citizenship. The applicant should have at least one Canadian parent

to get citizenship, receive a Canadian passport, and enjoy the benefits for an eligible Canadian citizen. The applicant, who is an adopted child of Canadian parents, has to be adopted outside Canada. Once approved, the applicant can enjoy the rights and freedoms as equal to a Canadian resident. This includes aboriginal people's rights, equality rights, legal rights, mobility rights, freedom of thought, religion, and speech as well as the right to peaceful assembly.

Temporary Work Visa For Canada

Canada, one of the widely growing economies, offers a host of opportunities to people all around the world. Each year, hundreds and thousands of individuals are hired on temporary basis by the Canadian organizations for a wide range of skills to fill in job positions which cannot be fulfilled by the existing workforce of the nation. Such workers must obtain a temporary work visa.

This liberal program, instituted by Citizenship and Immigration Canada allows eligible foreign workers to work in Canada for a specific period of time.

However, in order to work in the Canadian country as a temporary worker, individuals must be aware of the following essential information:-

- You employer may be required to obtain a Labour Market Impact Assessment (LMIA) to recruit you. LMIA is a document from Employment and Social Development Canada / Service Canada that allows your employer to hire a foreign worker.
- Your recruiter may have to pay a recruiter compliance fee and submit an "offer of employment" form to the Citizenship and Immigration Canada (CIC) via the Employer Portal. (In case you are exempted from the LIMA process, your employer must follow this step before you can apply for a permit).
- There is no need to submit any documents from a Canadian employer in case you
 are applying for an open work permit visa. Bear in mind, that if you are exempted
 from the LMIA process and receive an approval for an open work permit, you will
 have the liberty of working an employer of Canada who is not a part of the list of
 ineligible employers.
- You must meet the admissible requirements to enter Canada, stay in the country and obtain a work permit.
- A temporary worker visa does not allow you to permanently reside in Canada. In order to do so, you must prove your qualifications under an immigration category as a permanent resident.
- Your dependent children, spouse or common-law partner are eligible to accompany you to Canada, and, if they wish, they can apply for a job or study visa.

To apply for a temporary work visa for Canada, individuals must fulfill the basic eligibility criteria:-

- Convince the immigration officer that you shall leave the geographical boundaries of Canada at the end of your temporary work visa,
- Demonstrate your ability to financially support your and your accompanying family members during your stay in Canada and the return journey to your home, Obey the laws of Canada,
- Furnish a police clearance certificate stating that you have no records of criminal activities,
- Prove that you are and shall not be a danger to Canada's security,
- Furnish proofs that are you are in good health by submitting medical reports

- Prove that you shall not serve an employer who nones on the list of ineligible employers,
- Prove that you do not have any plans to serve an employer who, on a regular basis, provides striptease, escort services, erotic dance or erotic massages,
- Demonstrate that you have not worked in Canada for one or more periods which total up to four years after April 1, 2011 (some exceptions apply), and
- Provide the immigration office with any other documents that shall prove your worth to the country and the employer hiring you.
